## Matters Delegated by Council: None

#### **Biodiversity / Nature**

The Committee noted an update from the Clerk on progress on funding of the wildflower project.

The Committee discussed two proposals for enhancing Buckinghamshire Council's land at Three Hills as either woodland or aquatic habitat, in light of a site visit held recently.

A24/55 The Committee RESOLVED that: (a) the two proposals be combined into a single scheme comprising lakes and woodland; (b) the Biodiversity Steering Group should consider the practicalities of such a scheme; and (c) the Clerk should establish communications with the Buckinghamshire Council team that manages the site.

The Committee deferred discussion to its next meeting.

# **Playground**

Members noted a brief report from the Steering Group of a meeting with Sutcliffe Play, and that meetings with two more potential providers are anticipated in the coming weeks.

## **Burial Ground**

The Committee noted a report from the Clerk on attempts to re-home surplus rowan trees from the extension land and RESOLVED that any trees remaining in September should be chipped for use by the Council's Estates team.

#### **Tomkins Park**

The Committee noted the successful completion of all safety-related tree works from the 2023 survey, and that the next survey is due in spring 2025.

The Committee noted a report from the those members who attended a site meeting recently to consider the maintenance of the Park's margins and the practicality of a wildflower border adjacent to the eastern margin, and RESOLVED: (a) that the eastern margin should be cut back to a depth of approximately 5m along most of its length; (b) to defer consideration of a wildflower border until works to the eastern margin are complete; (c) that in the autumn, the northwestern margin of the park be cleared of dead trees, brambles and other undergrowth; and (d) to give further consideration to the management of the northwestern margin following its clearance.

Members noted the successful installation of a new bench on the corner of Sheep Street and Little Horwood Road.

## **Allotments**

Members noted an update from the Clerk on occupancy.

## **Public Hall Car Park**

Members noted the successful completion of repairs to the vehicle barrier.
